HAMPTONS FENCE WARRANTY

- 1. Our goods come with guarantees that cannot be excluded under the Australian Consumer Law.
- 2. Additionally, for a period of 7 years, Fences Galore (QLD) PTY LTD ('the Seller') warrants that the product is free from manufacturing defects such as peeling, flaking, rotting, chipping, cracking, blistering, or abnormal discoloration/fading** under normal atmosphere and weather conditions. The Seller's Hamptons fence products are manufactured with the highest industry UV protection with non-chalking TiO2 (titanium dioxide) and ultraviolet inhibitors with 100% virgin PVC.
- **After prolonged exposure to outdoor environments, all products will experience some gradual fading over time and is considered normal (up to a standard variation determined by Delta E color measurement, not to exceed Delta 5). Degrees of fading vary depending on geographical location, air pollution, exposure and other factors. If a product with a manufacturing defect becomes apparent and is reported to the Seller within 7 years of the date of purchase then the Seller may elect to either repair the defect or replace the product.

The conditions applicable to the warranty given by Clause 2 are:

- (a) The warranty shall not cover defect or damage which may be caused or partly caused by or arise through:
- 1) Failure by the Buyer to properly maintain the goods; or
- 2) Failure by the Buyer to follow instructions or guidelines provided by the Seller; or
- 3) Continued use of goods after any defect becomes apparent or would have become apparent to a reasonably person; or
- 4) Fair wear and tear, any accident or act of God; or
- 5) Scratching, abrasion, chipping or any other damage or deterioration caused by impact, accident, or misuse; or
- 6) movements, distortion, collapse or settling of ground or structure on which the fence is installed,
- 7) Excessive condensation and/or foreign matter ie dust, environmental matter, animal excrement; or
- 8) Attack from chemical agents, fumes, liquids or solids
- (b) The liability under the Warranty does not include:
- i) Labour costs associated with the removal or repair of the defective product, or installation of the replacement of product; or
- ii) Injury to persons, damage to property, loss of income, profit or business, or any other indirect loss arising from or caused in any way by the defective product.
- (c) The warranty shall cease if the product is repaired, altered or overhauled without the Seller's consent.
- (d) The Seller shall not be liable to compensate the Buyer for any delay in either replacing or repairing the product or assessing a claim
